Dear Superintendent Bernthal,

I am writing as chair of the Olympic Coast National Marine Sanctuary Advisory Council. We request that you support the governor's budget proposal to fund Washington Department of Fish and Wildlife's European green crab monitoring and removal efforts over the 2021-2023 biennium. The Advisory Council also endorses the Washington Sea Grant partnership proposal "Invasive European Green Crab — A Real Threat to Washington's Coastal Resources" for an additional \$1.2 million to continue monitoring and removal of the invasive European green crab.

Invasive European green crabs are a threat to Washington's lucrative shellfish industry by competing with native species and damaging habitat. The Washington outer coastal shellfish industry is valued at more than \$20 million in ex-vessel value annually for Dungeness crab. Monitoring and removal of invasive European green crabs will protect more than 2,000 tribal and non-tribal commercial fishing and processing jobs supported by the Washington shellfish industry. Populations of these invasive species already require trapping on the Makah reservation and in Grays Harbor and Willapa Bay. In the future, additional funding will likely be needed to expand assessment and management of this threat to Washington's shellfish industry and coastal jobs.

Thank you for your support of these current budget requests which will help protect the health and welfare of our coastal resources and communities.
